- 3. The Reeve and Secretary-Treasurer are hereby authorized, empowered, and directed to execute the said agreement on behalf of the Rural Municipality of Orkney No. 244 and to attach the Corporate Seal of the Rural Municipality of Orkney No. 244 thereto and to do or cause to be done all acts, matters, and things which may be necessary for the due performance and fulfillment of the terms of the said agreement.
- 4. The bylaw shall come into force and take effect from and after the day of the final passing thereof.

AN AGREEMENT BY AND BETWEEN THE MUNICIPALITIES COMPRISING THE PARKLAND REGIONAL LIBRARY

WHEREAS the Public Libraries Act, being Chapter 45 of the Revised
Statutes of Saskatchewan, 1969, provides that any municipality may by bylaw
associate with any other municipality or municipalities in the establishment
and operation of a regional library and may grant money for the establishment
and make an annual grant for the maintenance of such library:
AND WHEREAS the Council of the R.M. of
ORKENY #244 has in accordance with the Public
Libraries Act, passed a bylaw approving the association of the said munici-
pality, under the covenants, undertakings, and conditions of this agreement,
in the establishment and operation of the said Parkland Regional Library,
with the said municipalities and with any other municipality which executes
under seal a like agreement, and which is approved as an associated
municipality by the Regional Library Board hereinafter constituted:
NOW THIS AGREEMENT WITNESSETH that the R.M. of
ORKENY #244 hereby agrees to associate itself with
the other associated municipalities listed in the Schedule annexed hereto in
the establishment and operation of a regional library pursuant to The Public
Libraries Act and the regulations made thereunder and upon the following
covenants, undertakings and conditions:

1. Establishment

The associated municipalities hereby agree to associate each with the others in the establishment and operation of a regional library to be known as the Parkland Regional Library.

2. Purpose

The purpose of the said regional library shall be to provide public library service for the people within the boundaries of the associated municipalities.

3. Term

- a. Subject to the provision for disassociation in Clause 4, the term of this Agreement shall be from the 1st day of January 1979 to the 31st day of December 1981 at which time, if no notice has been given pursuant to subclause (b) hereof, the term shall be extended automatically for a further period of three years and similarly at the end of each subsequent three year period.
- b. Any or all of the covenants, undertakings, and conditions herein contained may on the request of the said Regional Library Board, or of any associated municipality, be renegotiated at the end of the term or at the end of any subsequent three year period, if at least three months notice in writing of the revision requested is given to the secretary of the said Regional Library Board.
- negotiations are subject to approval by a majority vote at an Annual Meeting of the Board.

4. Disassociation

Any associated municipality may disassociate iteself from the other municipalities in the establishment and operation of the said Regional Library according to the following procedures and principles laid down in Saskatchewan Regulation 88/69 Section 9:

- the Board, written notice of its intention to withdraw at least two years prior to the date of withdrawal.
- b. The effective date of withdrawal shall always be the 31st of December of a particular year.
- c. The notice of withdrawal is effective only if supported by a resolution of the council passed within 30 days from the date of the official notice of withdrawal.
- d. Not later than 60 days prior to the effective date of withdrawal, the Board of the Regional Library shall give notice in writing to the council of the effect of the withdrawal on library service to the residents of the municipality concerned.

5. Board

The general management, control and operation of the said Regional Library shall be under the supervision and direction of a Regional Library Board, hereinafter called "The Board", constituted and with the powers, duties and responsibilities as set out in the regulations made under the Public Libraries Act.

6. Meetings and Quorum

- a. The Board shall meet at least once a year and at such other times as it deems advisable.
- b. The annual meeting of the Board shall be held before the end of February each year, on a date to be fixed by the Executive Committee.
- c. At all meetings of the Board, members representing one-third of the associated municipalities shall form a quorum.

7. Executive

The Executive shall consist of ten members including the Chairperson and Vice-Chairperson. Each member shall be chosen for a two year term, with half the positions being up for re-election each year. The Executive may fill any vacancies which occur between meetings of the Board.

8. Headquarters

The Headquarters of the said Regional Library shall be in the City of Yorkton in such space and upon such terms as may be agreed upon between the Board and the Minister of the Provincial Government in charge of Libraries.

9. Housing of Books

The accommodation provided by each municipality, in accordance with the said regulations for the care, housing, and distribution of books shall be bright, attractive, well heated, well kept, and wherever possible shall:

- a. include a reading room
- b. be located on a ground floor
- be located near the centre of the town, village or hamlet.

10. Finance

a. The said Regional Library shall be financed by grants from the Provincial Government and by payments made by each of the associated municipalities, which payments shall be calculated as follows:

1979 Rates are:

- \$3,56 minimum for each resident of the City of Yorkton.
- 2.97 minimum for each resident of the City of Melville.
- 2.02 minimum for each resident of a municipality being a Town of a population of 800 or over.
- 1.43 minimum for each resident of a municipality being a Town or Village under 800 population.
- 1.31 minimum for each resident of a municipality being a Rural Municipality.

For the remaining two years of the Agreement period, the rate is to be determined by adding 10% to the rate of the previous year.

Those municipalities with populations of 50 or under and without any library facility, will be charged an annual levy rate of 1 (one) cent.

- b. The amount of the annual payment for each resident of the associated municipalities as herein provided may be revised with effect from any year during the term of this Agreement, provided that the revision is approved by a majority vote at the annual meeting of the Board.
- c. Any associated municipality may if it so desires agree with the Board to increase the amount of its payment as determined above, in consideration for increased services proportionate to the said increase in the amount of its payment.
- d. Payments of the associated municipalities shall be made on a semi-annual basis, one-half before March 1st, and the other half before September 1st of each year.

11. Additional Members

Any municipality may become an associated municipality upon executing under seal an Agreement in the same covenants, undertakings, and conditions as are herein contained, provided its application is approved by the Board and by the Minister of the Provincial Government in charge of Libraries.

12. Discontinuance

IN WITNESS WHEREOF THE

In the event of the discontinuance of the said Regional Library,
the terms of disestablishment and disposal of assets shall be
determined by the Board, subject to the approval of the said Minister.

 - \$1.80 minimum for each resident of a municipality being a Rural Municipality.
- 1983 \$3.22 minimum for each resident of a municipality being a Town of a population of 800 or more.
 - \$2.29 minimum for each resident of a municipality being a Town or Village under 800 population.
 - \$2.09 minimum for each resident of a municipality being a Rural Municipality.
- 1984 \$3.80 minimum for each resident of a municipality being a Town of a population of 800 or over.
 - \$2.70 minimum for each resident of a municipality being a Town or Village under 800 population.
 - \$2.47 minimum for each resident of a municipality being a Rural Municipality.
