

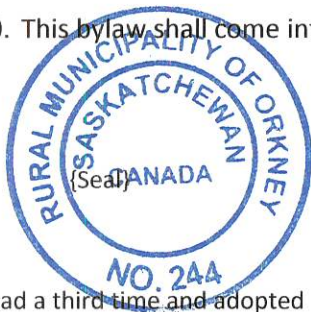

BYLAW No. 9/2023

A BYLAW TO PROVIDE FOR THE NUMBERING OF HOUSES AND OTHER BUILDINGS

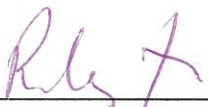
The Council of the Rural Municipality of Orkney No. 244 in the Province of Saskatchewan enacts as follows:

1. This bylaw shall be referred to as the "Civic Addressing Bylaw."
2. A uniform system of numbering houses and other buildings is hereby established and is shown the attached maps identified as Schedules A, B, C, D, E, F, as appended hereto and forming a part of this bylaw.
3. A separate number shall be assigned for each specified number of feet (or specified number of meters) of frontage or per lot as indicated below with consideration given for both current and future potential subdivisions as well as existing access.
 - a. Schedule A: Ashcroft Lane: PT SE 23-25-04-W2: 216 feet (65.84 meters) of frontage
 - b. Schedule B: Collacott: PT NW 33-25-04-W2: each lot or parcel frontage
 - c. Schedule C: Copperhead Service Road: PT SE 26-25-04-W2: 118 feet (36 meters) of frontage
 - d. Schedule D: Pleasant Heights: PT SE 4-26-04-W2: each lot or parcel frontage
 - e. Schedule E: Rae Leah Road: PT SE and SW 18-26-04-W2: 246.06 feet (75 meters) of frontage
 - f. Schedule F: Rocky Mountain Way: PT NW 24-25-04-W2: 214 feet (65.23 meters of frontage)
: PT SW 24-25-04-W2: 219.4 feet (66.88 meters of frontage)
 - g. Schedule G: Schrader Drive: PT NE 14-26-04-W2: each lot or parcel frontage
4. Each approach shall bear the number the number assigned to the improvement(s).
5. In case a house or building is occupied by more than one family dwelling unit or business, each separate front entrance of said house or building shall bear the same number extended with a letter of the alphabet beginning with the letter "A" and proceeding with as many as are required.
6. Numerals indicating the official number of each house or building, or each front entrance shall be posted in a manner as to be visible from the street on which the property is located and shall be done so at the property owner's expense.
7. The Administrator shall be responsible for maintaining the numbering system and shall keep a record of all numbers assigned under this bylaw.
8. All existing numbers of houses and other buildings not now conforming to the provisions of this bylaw shall be changed to conform to the system herein adopted.
9. Bylaws 10/2010, 12/2011, 12/2018, 2-2020, 4-2021 and 4/2022 are hereby repealed.
10. This bylaw shall come into effect on the day of its final passing.

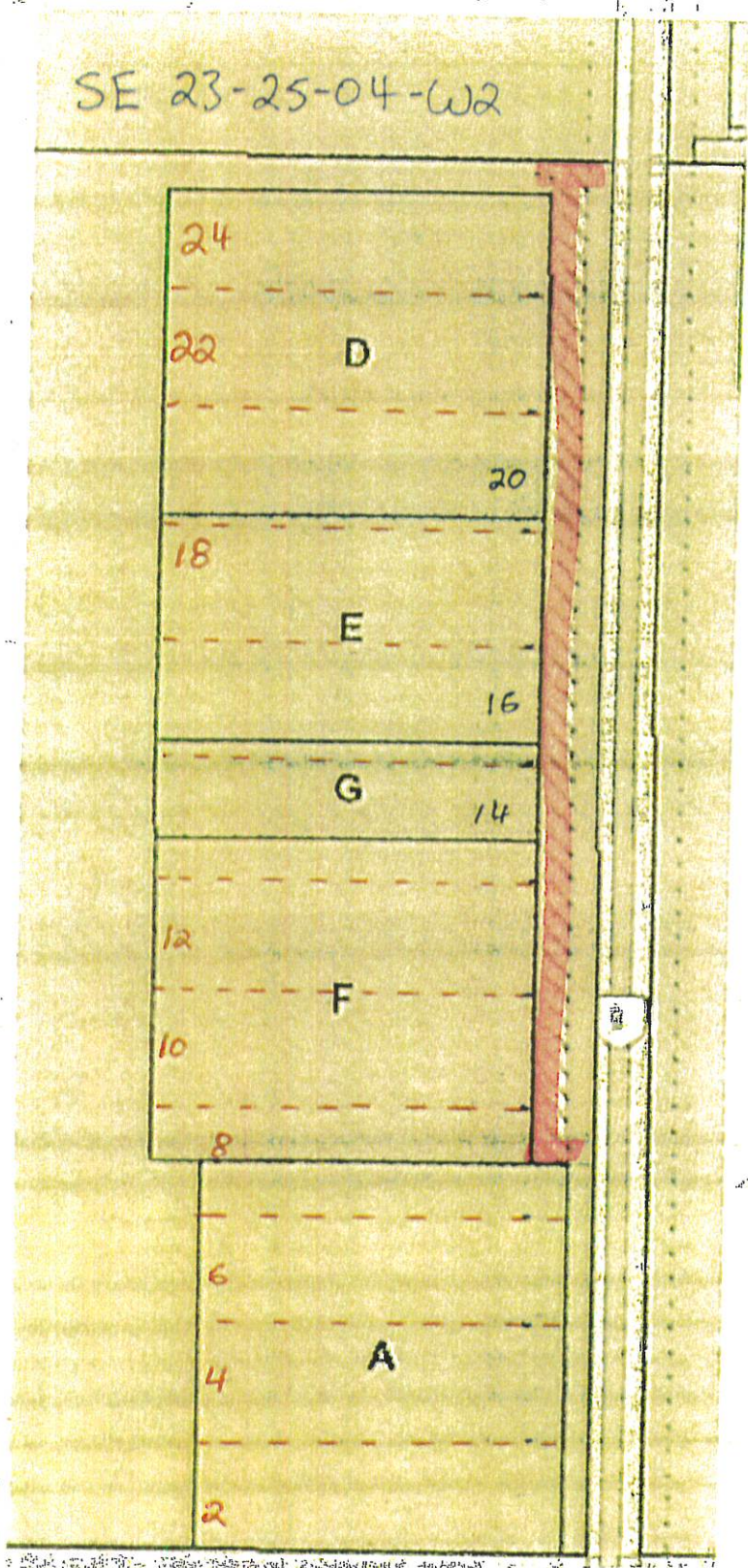

Ashcroft Lane

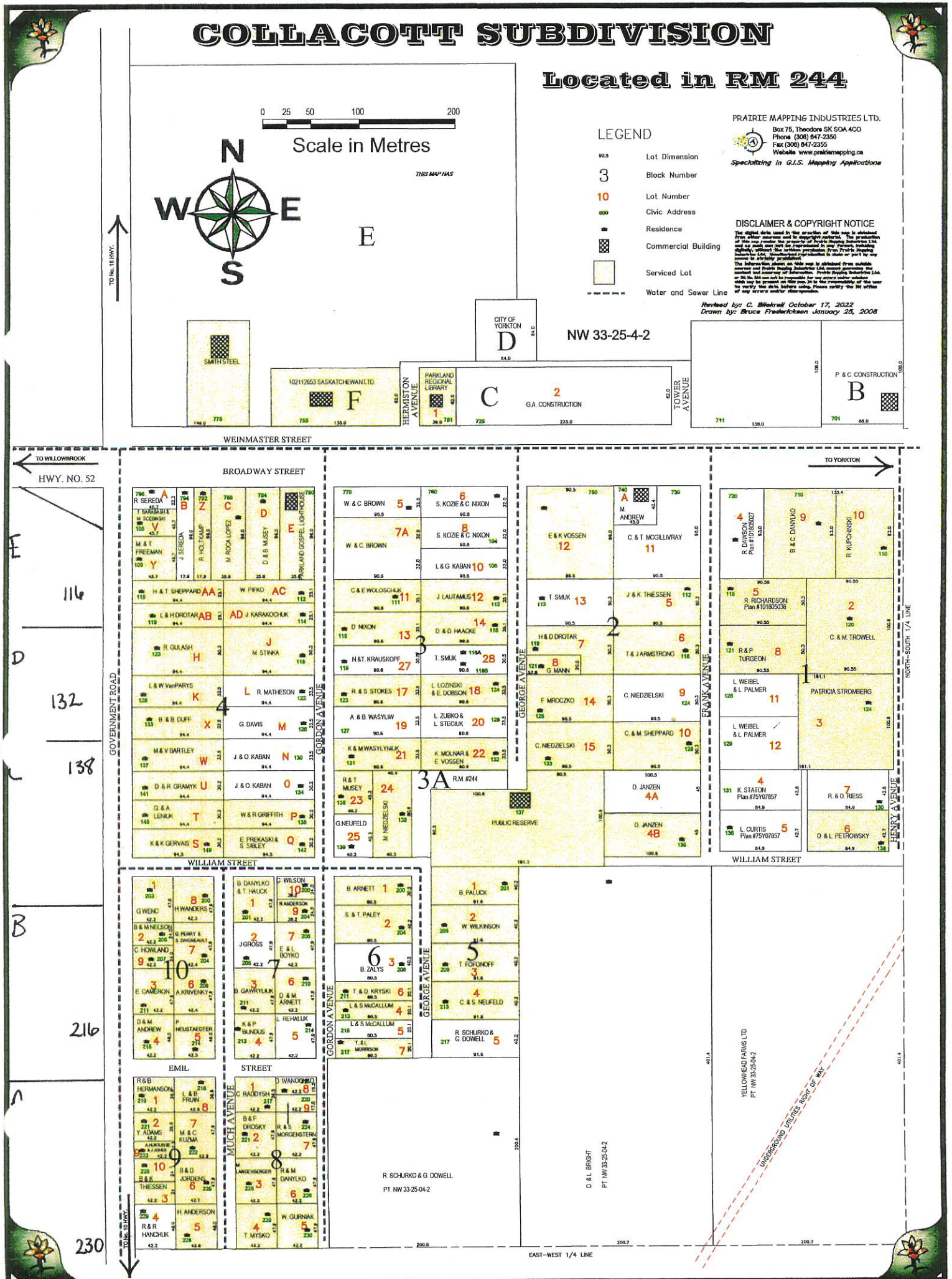

COLLACOTT SUBDIVISION LOCATED ON PT NW 33-25-04 W2

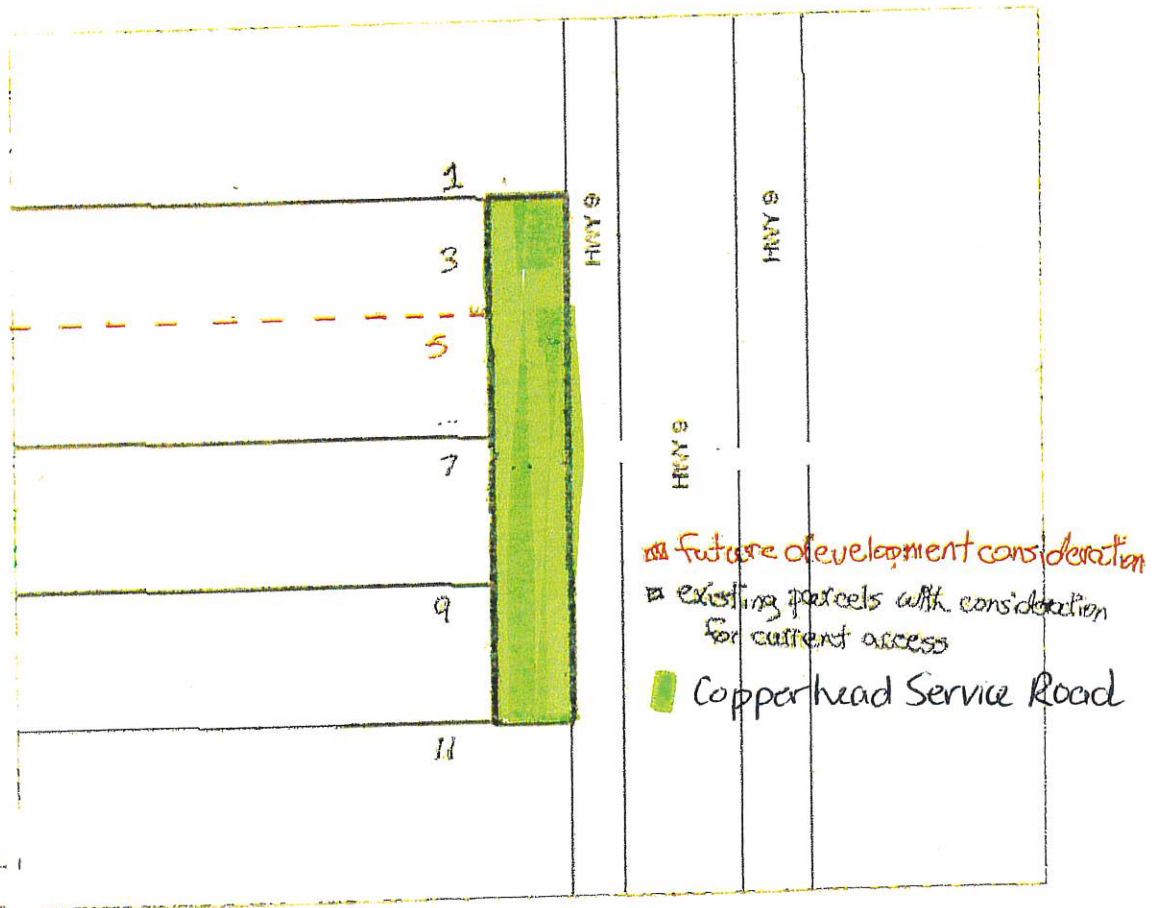

COPPERHEAD SERVICE ROAD LOCATED ON PT SE 26-25-04 W2

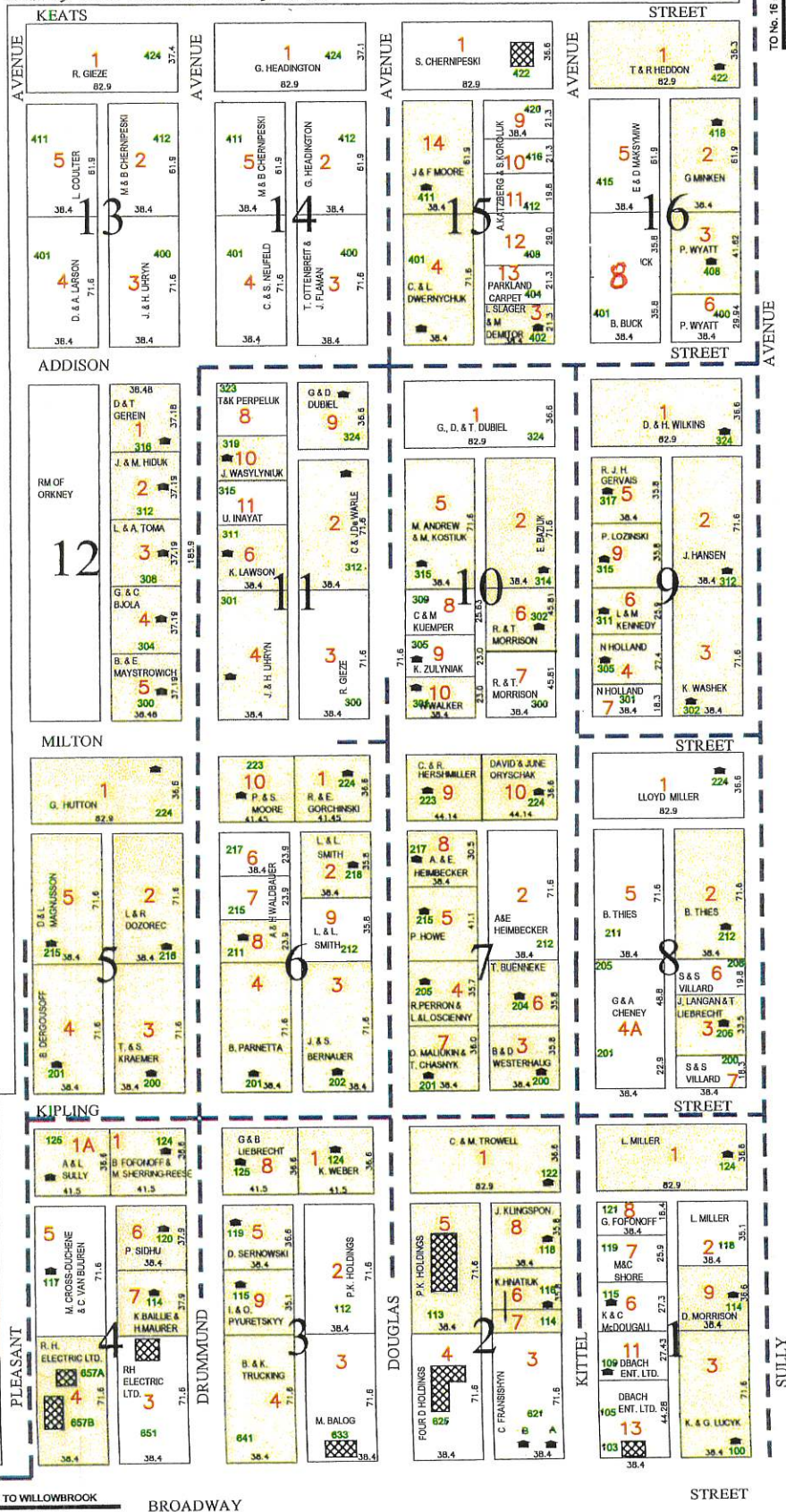

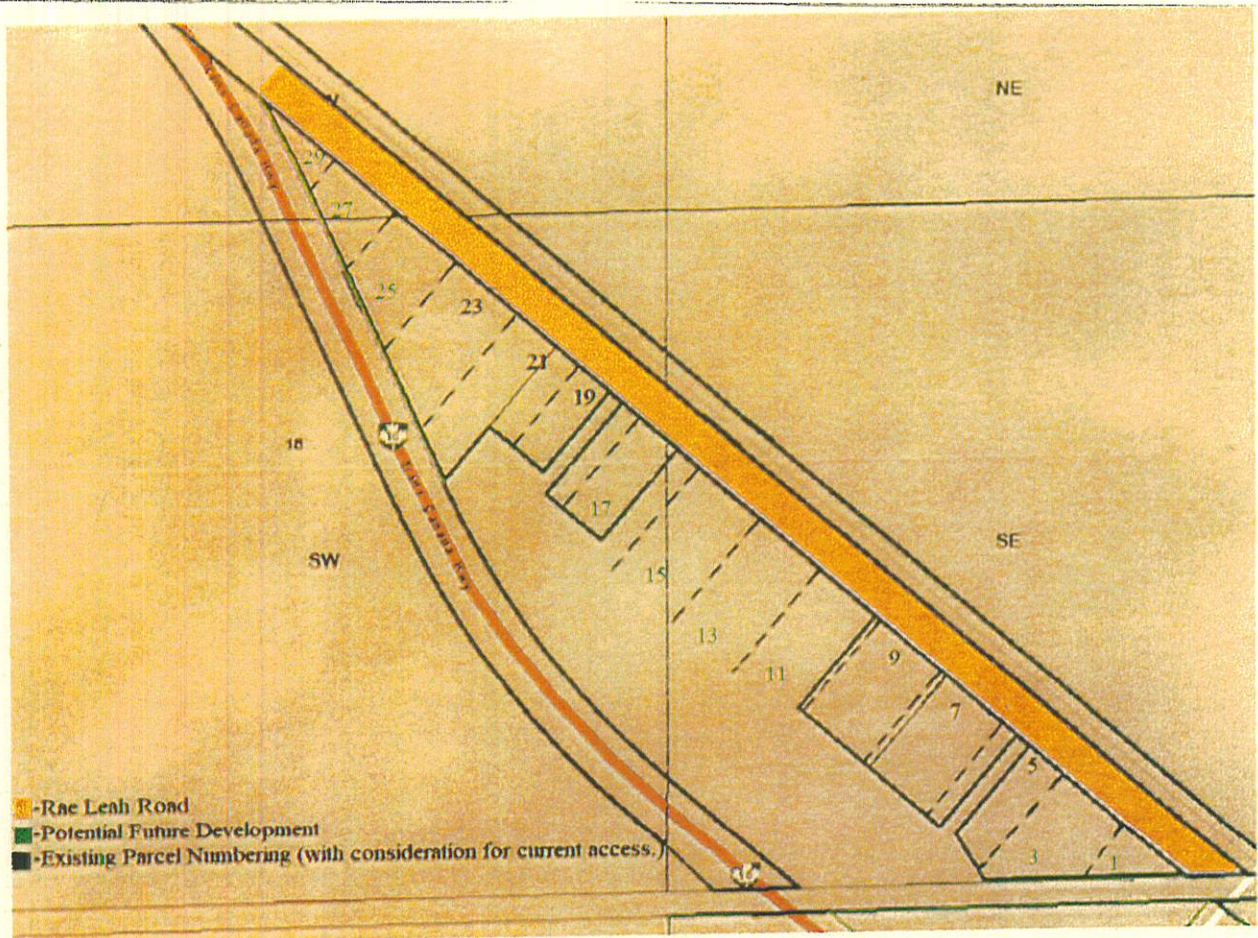

RAE LEAH ROAD LOCATED ON PT SE & SW 18-26-04 W2

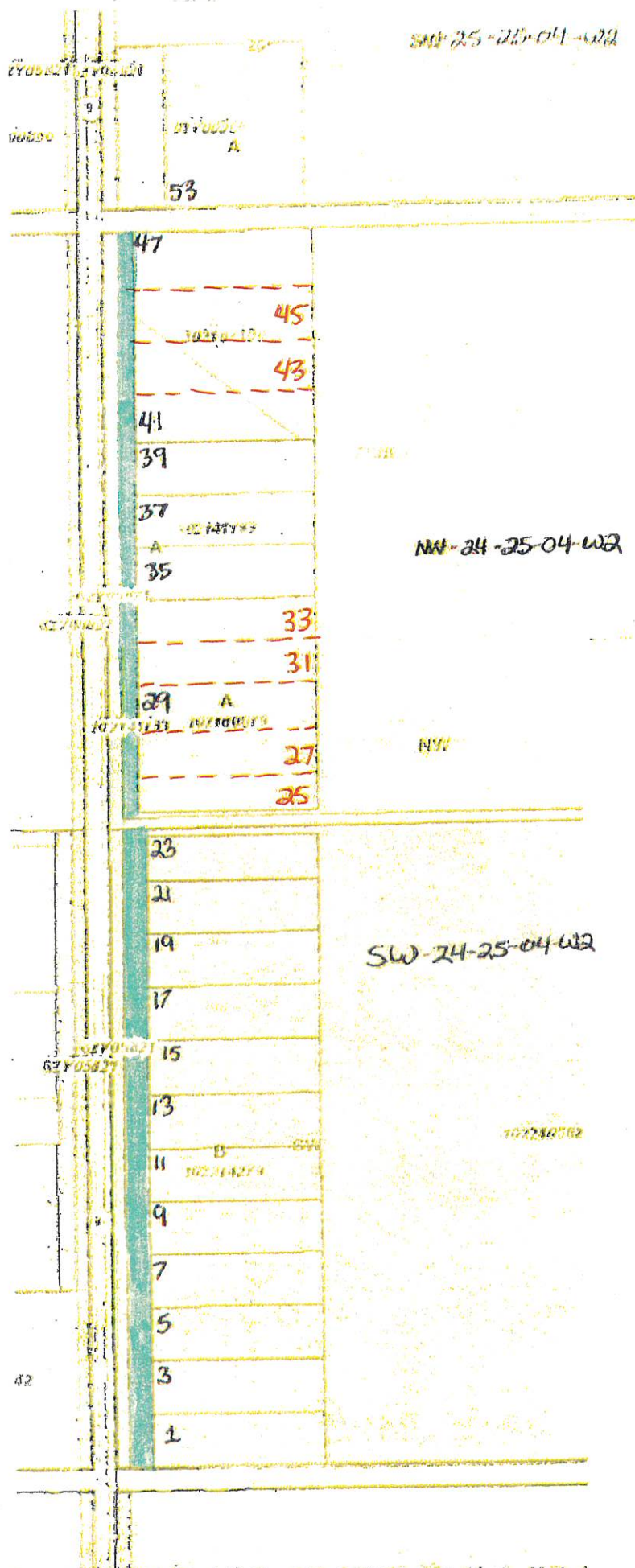

ROCKY MOUNTAIN WAY LOCATED ON PT NW & SW 24-25-04 W2

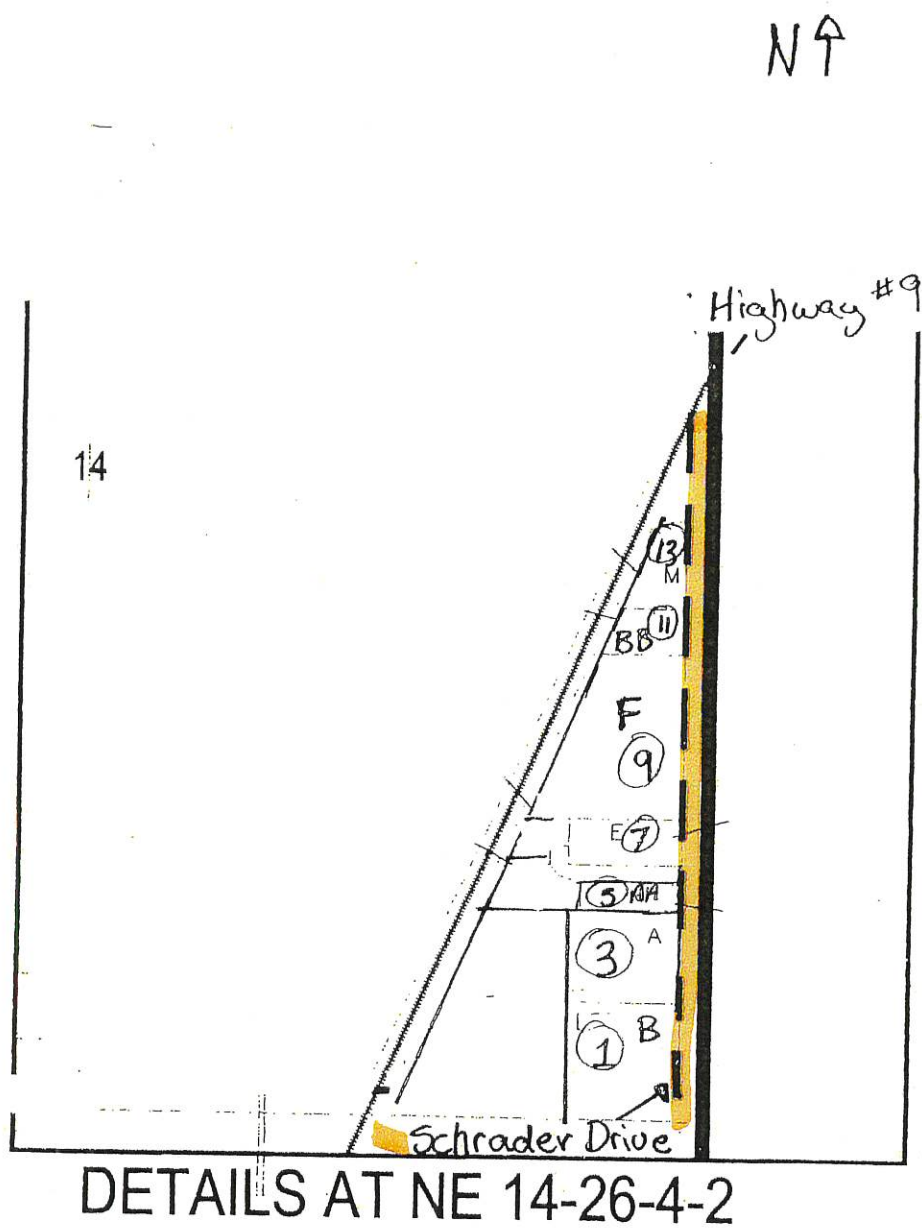
