BYLAW No. 8/2026

**A BYLAW TO AUTHORIZE A SPECIAL TAX FOR SOLID WASTE AND RECYCLING COLLECTION AND DISPOSAL
IN THE MAPLE GROVE ESTATES SUBDIVISION**

The Council of the Rural Municipality of Orkney No. 244, in the Province of Saskatchewan, enacts as follows:

1. Authorization for Special Tax

A Special Tax be levied against all benefiting lands, as per Appendix A, for the purpose or service of solid waste and recycling collection and disposal to be completed within the current year.

The collection and disposal of solid waste and recycling is hereby authorized on each occupied residential property with an improvement located in the subdivision area of Maple Grove Estates.

2. Costs for Special Tax

The estimated cost of the solid waste and recycling collection and disposal from January to December of this year is nine thousand three hundred and seventy-four dollars and nineteen cents (\$9,374.19).

The rate of special tax charged against each occupied residential property is a flat rate of Three Hundred and Two dollars and Thirty-Eight cents (\$302.39) per parcel of land to be levied against all assessed owners of a residential improvement according to their respective parcel of land.

3. Errors or Omissions

Any person who considers that an error or omission was made in the application or calculation of the special tax on his or her property may notify the municipality in writing by May 11, 2026 requesting the council to review the application or calculation of the tax rate regarding the property in question.

The administrator will notify the persons, who have requested a review, of the time and date the council will meet to hear and review the requests.

4. Levy of Tax

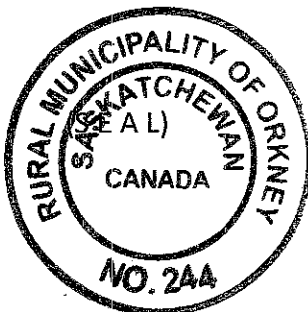
The taxes that are levied will be added to the tax roll as a special tax against the property, when they become due and payable, and are recoverable in the same manner as other taxes.


5. Repealing of Bylaw


