## ROAD MAINTENANCE POLICY

### 1. PURPOSE

- 1.1. Council adopted the following policy to offset some of the administrative costs for road maintenance agreement applications.
- 1.2. To establish minimum criteria of aggregate hauling, individual road maintenance agreements shall be required for non-agricultural hauls in excess of 200 yards of material or equivalent over a five or less working day period with the RM of Orkney.

### 2. POLICY

- 2.1. **Fees** Should the municipality require road maintenance agreements with local contractors, the contractor will be required to pay the following fees:

Actual road maintenance fees as per each approved agreement	Maximum Legislated rates apply
Additional fees for noncompliance	Up to \$500.00

- 2.2. **Application** All applications for Road Maintenance Agreements must be completed on the attached request form and submitted to the R.M. office.

#### 2.2.1. The following guidelines are to be met when conducting a road haul:

- Dust suppressant is to be laid 150 meters for all areas where residence activity is present and for the duration of the haul;
- Must yield to oncoming traffic and abide to a maximum speed of 60 km on municipal road and a maximum speed of 40 km in front of residences;
- Conduct a pre-inspection of the road prior to haul and a post-inspection once the haul is completed, administered by the Public Works Manager;
- A concentrated haul is defined as a minimum of twenty trips per day, combined with all trucks. In the case of a concentrated haul, grading will be done by the RM once every week, any additional grading needed will be the responsibility of the hauler.
- After the completion of haul, any loss of gravel is to be replaced by the hauler with ¾ inch crushed type 106 or 108 road gravel (as determined by the R.M.) at a minimum of ten percentage replacement of the overall material hauled.

\* Example if a hauler moves 8,000 tonne material is replaced at 80 yards per mile, if a hauler moves 10,000 tonne of material gravel is replaced at a rate of 100 yards per mile.

- All Road Maintenance Agreements will be approved by the Administrator and the Public Works Manager with notification to be given to the Division Councilor.
- All approvals will require payment to be received in full to the municipality for the estimated haul calculated by the Administration on the ***Estimation for Road Maintenance Agreement*** form, prior to the commencement of the haul.

### **2.3 Failure to Submit**

Haulers who fail to submit an Agreement before commencing a haul shall forfeit future Road Maintenance Agreements as determined at Council's discretion.

### **3. GENERAL**
